General terms and conditions of sale Zumex Group, S. A.

These general conditions of use, as well as the user manual, guarantee conditions and, if applicable, the purchase order, together with any other terms including privacy or cookies policies, constitute the entire agreement between zumex group, s.a. and the customer, which establish the conditions applicable to the purchase and sale of goods sold by zumex group, s.a. it is recommended that you read this agreement carefully.

1. Validity and application.

1.1. These General Conditions of Sale will apply to all "quotes", "proforma invoices", "invoices" or "sales orders" that have been confirmed by the Customer's signature.

1.2. For the purposes of these General Conditions of Sale: "sales order" will be

1.2.1. understood as the order received by ZUMEX GROUP S.A., completed by the Customer with all details required in section 3.1., and signed by the Customer.

1.2.2. "Quote" or "proforma invoice" will be understood as the document issued by ZUMEX GROUP S.A. prior to the order confirmation for the Customer's approval.

1.2.3. "Order confirmation" is the document issued by ZUMEX GROUP S.A., accepted by the Customer.

1.3. These General Conditions of Sale constitute the entire agreement between the parties. Any changes must be made in writing and signed by a duly authorised representative from each of the parties.

2. Products.

2.1. ZUMEX GROUP S.A. manufactures and/or sells and distributes the machines, parts, components and devices that appear in its current official catalogues.

2.2. ZUMEX GROUP S.A. reserves the right to amend product specifications without prior notice.

3. Orders and deliveries.

3.1. All orders will be provided in writing, via fax or e-mail, indicating at least the following data:

3.1.1. The issue date.

3.1.2. Reference number and description of the product.

3.1.3. Number of units.

3.1.4. Price.

3.1.5. Payment method.

3.1.6. Transport conditions.

3.1.7. Delivery address.

3.2. Any change to the conditions of sale of our products concerning prices, shipping fees and payment methods must be previously agreed with our sales managers.

3.3. The quotes sent to our Customers for their acceptance will be valid until the date indicated therein.

3.4. The prices indicated in the rates do not include taxes and are understood to be "ex-factory" from Moncada (Valencia). Deliveries are made 2 days after confirmation of the order if stock is available, and on the agreed date otherwise. In the event of prepayment, the delivery time will commence from the receipt date of the funds.

3.5. Urgent orders will be processed by express couriers at the Customer's expense, subject to their approval.

4. Payment method.

4.1. The method of payment for products supplied by ZUMEX GROUP S.A. is as follows:

4.1.1. First order: cash payment in advance.

4.1.2. For subsequent orders: the conditions of payment will be established by ZUMEX GROUP S.A. as part of its distribution strategy.

4.2. Failure to pay an invoice on its due date, once the Customer has been

notified, authorises ZUMEX GROUP S.A. to cancel the credit or payment conditions granted to the Customer, and to suspend the shipment of orders until the amounts owed have been paid.

5. Guarantee.

5.1. ZUMEX GROUP S.A. guarantees that all products manufactured by ZUMEX GROUP S.A. and the materials of which they are composed are free from defects for the period and for the use indicated in the "Guarantee" section of the Use Manual and in the Manual itself, starting from the issue date of the invoice. The product guarantee and the exclusions are set forth in these General Conditions, the User Manual in which the "Guarantee" section can be found, and these documents can be consulted for further information regarding the scope of the Guarantee and its exclusions.

5.2. Requests for spare parts under guarantee will be accompanied by the serial number of the machine, the invoice number and its date. ZUMEX GROUP S.A. will not be liable for damage to or by the machines resulting from incorrect or improper storage, incorrect or improper installation, incorrect or improper use, damage caused by improper care and cleaning, or an incorrect application, abuse or operation of the machines outside the normal operating parameters specified in the manufacturer's user manuals.

5.3. Provided that the machines are stored, installed and used within the aforementioned normal operating parameters and cleaned only by approved means, as detailed in the User Manual, in the event that a defect and/or malfunction of the Product manufactured by ZUMEX GROUP S.A. is detected, ZUMEX GROUP S.A. offers the Customer the basic guarantee of the right to replace or repair that component of the new product purchased, provided that the defect and/or malfunction is due to a manufacturing fault that entails a deficiency in its normal operation, and which is found in the product's Basic Conditions of Guarantee.

5.4. For those products marketed but not manufactured by ZUMEX GROUP S.A., in all matters relating to manufacturing defects, product malfunctions or damage caused to or by the machines through no fault of the Customer, the original manufacturer will be liable for the guarantee, under the terms stipulated in the guarantees granted by the manufacturer. In these cases, ZUMEX GROUP S.A. will only manage the incident through the procedure detailed in section 6.3 of these conditions.

5.5. The guarantee of each of the components of replaced or repaired products will be limited to the duration of the original guarantee of each one. Therefore, the replacement and/or repair of parts under guarantee will not extend past this guarantee period.

5.6. The Customer is obliged to check the integrity of the product as soon as it is delivered.

5.7. In the event that, immediately upon receiving the Product, the Customer does not complain about possible defects and/or damages caused by its transportation, the liability for these defects and/or damages will be borne solely by the Customer, and they will not be able to claim anything from ZUMEX GROUP S.A. for this reason.

5.8. The Guarantee granted in the terms above is granted solely to the Customer and cannot be transferred to third parties.

5.9. For all matters not set forth in these conditions, the Basic Conditions of Guarantee, applicable to each product, will also apply.

6. Technical Support Service.

6.1. Generally, any request for technical assistance and relating to the products manufactured and marketed by ZUMEX GROUP S.A. can be sent to its Technical Support Service, preferably by email. The sending email for Pineomatic requests is service.pineomatic@zumex.com and for the rest of Zumex products service@zumex.com. Once the request has been accepted, ZUMEX GROUP S.A. may choose to repair or replace the products, in accordance with the Guarantee applicable to each product.

6.2. All requests for technical assistance to ZUMEX GROUP S.A. must include the following information:

6.2.1. Serial number of the machine.

6.2.2. Brief explanation of the incident.

6.2.3. Photo or video of the incident.

6.2.4. Reference of the affected parts causing the claim.

6.3. The request for technical assistance regarding products marketed but not manufactured by ZUMEX GROUP S.A. must also be carried out in accordance with the procedure described in the previous sections. However, the request will be handled by ZUMEX GROUP S.A. and sent by it to the original manufacturer, whereby the request will be resolved by the original product manufacturer in accordance with the latter's Guarantee. Accordingly, ZUMEX GROUP S.A. will not be liable to the Customer for the final outcome of the request. If they disagree with the outcome of the request made, the Customer can contact the original product manufacturer.

7. Claims.

7.1. For any order-related claims, it is essential that the Customer, upon receiving the goods, indicates any incident regarding their condition, packaging or number of packages on the delivery note given to them by the courier, which they sign. This incident will be reported by fax or e-mail to the Sales Administration Department, attaching a copy of this delivery note within a maximum period of 24 hours from receiving the goods, after which it will be understood that they have been accepted by the Customer.

8. Return conditions.

8.1. Product returns arising from any non-conformity must be communicated and authorised by ZUMEX GROUP S.A. Once the return has been authorised, the Customer must return the goods within a maximum period of 3 days.

8.2. All returns must be in their original packaging and duly documented, indicating the reason for the return. Any returns that do not meet these requirements will not be accepted.

8.3. When the reasons for the return are unrelated to ZUMEX GROUP S.A., all costs generated by the return will be charged to the Customer.

8.4. When the reasons for the return are attributable to ZUMEX GROUP S.A., the return will be made by transportation authorised by it.

9. Safety.

9.1. ZUMEX GROUP S.A. assures that the products and the procedures used in the manufacturing of its products comply with the current regulations detailed in the User Manual and in its current official catalogues.

9.2. Any changes to product specifications made by the Customer will be under their sole responsibility.

10. Data protection. Confidentiality.

10.1. ZUMEX GROUP, S.A. carries out an automated processing of personal data. ZUMEX GROUP, S.A. will only allow access to personal data when this is necessary for executing the purpose of the Contract.

10.2. In compliance with current legislation, ZUMEX GROUP, S.A. hereby informs and undertakes to:

10.2.1. Not apply or use the personal data obtained for purposes other than those contained in this Contract and to not assign them to third parties, not even for their conservation. The purposes and bases for the legitimacy of the processing are as follows:

10.2.1.1. The management of the pre-contractual and contractual relationship in which the Customer (data subject) is a party.

10.2.1.2. The fulfilment of its contractual and legal obligations.

10.2.1.3. In the legitimate interest of the data controller (ZUMEX GROUP, S.A.) regarding the organisation, management and analysis of its business.

10.2.2. To transfer the obligations mentioned in the preceding paragraphs to the staff members engaged in the performance of this Contract. Except for the purposes described above and on the basis of the aforementioned grounds of legitimacy, either by itself or by third parties, ZUMEX GROUP, S.A. will not perform international data transfers.

10.2.3. Once the contractual performance has been fulfilled, unless otherwise indicated by the applicable legislation for the purposes of retaining certain types of data or information, the data controller will delete or, failing this, anonymise the personal data relating to the Contract.

10.2.4. For any query or question, or to exercise the rights inherent to the data subject, they can contact ZUMEX GROUP, S.A. using the following email: marketing@zumex.com.

10.2.5. The data subject may also contact the competent data protection supervisory authority, in this case, the Spanish Data Protection Agency through the means made available by the latter at the following link.

10.3 Connected machines. Some of our machines are connected machines, that is, they have a series of devices incorporated that provide the Customer and ZUMEX GROUP, S.A. with information regarding the performance and operation of the specific machine. In some models of these machines, these devices, without the need for any action by the Customer, may come pre-activated from the factory and the information they issue is seen by ZUMEX GROUP, S.A. However, this information only discloses the identification, status and operation of the machine and its approximate geolocation. These data will be processed by ZUMEX GROUP, S.A. in an aggregated macro form, that is, avoiding the identification of the machine user, and only for analysis and research purposes in relation to the quality of our products.

11. Applicable law and jurisdiction.

11.1. These General Conditions of Sale will be governed by Spanish law. The parties expressly waive any other jurisdiction that may correspond to them and submit to the Courts and Tribunals of Valencia to settle any differences that may arise from these General Conditions of Sale.

12. Use of the brand.

12.1. ZUMEX GROUP S.A., or, where appropriate, the manufacturers of the products marketed by ZUMEX GROUP S.A., are the legitimate owners of all elements of their products and services, especially trademarks, patents, designs and drawings or any other protectable elements relating thereto. Therefore, any use of these elements in products or parts thereof, company names, promotional, commercial or trade documentation, in advertising, informative, Internet or any other media is legitimised for their owners and their use by third parties other than ZUMEX GROUP S.A. or the manufacturer of the products will require their prior express and written authorisation.

13. Validity of the Pricelist
